#### Angola Summary Sheet

As the world comes closer to achieving eradication, GPEI will wind down its operations, requiring GPEI-funded countries to proactively plan for a transition away from GPEI resources. This document on the Republic of Angola intends to provide an overview of the status of planning for this transition of assets and infrastructure by Angola. # **Background:** GPEI Funding Ramp Down

Angola has not reported any cases of wild poliovirus since July of 2011. This achievement was made possible through efforts led by the Government in partnership with WHO, UNICEF, CORE Group, Red Cross and other agencies

The projected budget for 2019 communicated to Angola by GPEI is US \$ 4,486,000. Angola is also in the process of transitioning from GAVI funding support, and from2018, Angola will be considered a fully self-financing country in terms of its immunization programme.

Awareness raising	Key stakeholders were engaged through letters from WHO to the Ministry of Health (MoH), followed by a series of discussions and a presentation to the Immunization Coordination Committee (ICC).			
Coordination	The Transition Coordination and Monitoring Technical Group (CMTG) was created. The progress on polio transition was presented to the ICC during their last meeting. In an effort to streamline coordination with the MoH, the ICC and various partners are expected to merge into one coordination body called the "Partner Forum".			
Evidence	To understand the full range of polio assets, a mapping was completed in September 2016. The WHO technical assistance ramp down plan was agreed with the MOH for 2017 and 2018. For the asset map, click on the adjacent "Evidence" link".			
Strategic Options	A polio transition workshop was conducted on 16-17 August 2017. The workshop report includes the strategic options for polio transition and is under review by the CMTG.			
Vision for the future	The country plans to develop a polio transition proposal based on the strategic options under consideration by the CMTG. Since the GAVI transition plan ends in 2017, integration with immunization programme activities will require a separate request for Gavi financing.			
Transition Plan	The National Transition Plan is under development. Once potential donors have been identified, a memorandum of understanding will be developed to confirm their support for the implementation of polio transition.			

#### Strategic Options for Transition

Angola's overall strategy for transition of polio-essential functions is to transfer responsibilities to the government by 2022. The objective of the transition is to transfer existing polio eradication activities and functions to existing structures and programs of the Ministry of Health and its partners to ensure the sustainability of the gains achieved, reduce the risk of any reintroduction of poliovirus, institutionalize the lessons learned from implementation of this program and continue to support provinces and other public health programs. As such, the strategy involves strengthening the capacities of the Health System (National, Provincial and Municipal Level) over a four to five-year period (i.e. from 2018 to 2022) through a technical assistance programme to be created at the Ministry of Health with support from WHO

## Next steps

In the short-term:

Since Angola's economy relies heavily on oil production, the global decline in oil prices has greatly impacted the financial landscape (i.e. national revenues)

Competing priorities (e.g. recent election, health emergencies, etc.) for programme partners

Delay in financial health interventions to secure government funding for transition

### Challenges

New Government after elections may require a re-initiation of activities and a shift in engagement (advocacy) and coordination (i.e. coordination with Ministry of Finance)

□ Extension of support of the polio transition consultant with potential for embedding continued support within the Ministry of Health to complete the transition planning process
