GPEI inspiration / Good news sharing	12 Nov	 The Government of Sudan firmly committed more than US\$ 4 million to make up for the budget needs of the outbreak response, beyond GPEI's financial commitment. Inspirational to hear how Rotarians are really trying hard to support the efforts underway in outbreak countries, and engaging governments on domestic resourcing. 	
	5 Nov	 Closure of cVDPV2 outbreak emergencies in the African region. Launch of the emergency call to action for polio and measles outbreak prevention and response. Productive WHO/UNICEF team leads meeting with officials in Pakistan.
