# Approach to measure and assess quality of transition plans and implementation

1. Identify granular elements of polio transition, and a way in which they could be measured.
2. Develop a high-level monitoring framework to enable measurement of progress and tracking of management

# GPEI Measures of Transition Success

Are plans and actions in place for:

1. Country transition
2. Agency transition and implementation
3. PCS development and approval
4. Donor level engagement in transition process
5. Engagement of technical programs outside of polio (other disease control programs, other immunization funders and implementing partners)

# Measurable elements of successful polio transition on the national (country) level:

1. Government ownership
2. Implementation of polio essential functions
3. Measurable implementation of transition plans
4. Sustainability of country transition plan
5. Integration of the plan in national health priorities
6. Sustainable and realistic financing strategy

# 1. Government Ownership

Is the plan fully owned and endorsed by relevant government authorities, including the Ministry of Health?

- Was the plan reviewed by ICC?
- Have other government Ministries, including Finance, Budget & Planning, and Labor, provided input into the plan?

## 2. Polio Essential Functions

Have the future owners of the functions been identified?

Is there a detailed plan with clear ownership for ensuring sustainable implementation of functions needed to maintain the world polio free beyond global certification as per the PCS?

- Quality surveillance
- Effective outbreak response
- Virus containment
- Immunization with IPV

### 3. Implementation Preparedness

Is there a measurable implementation plan for transition that all stakeholders have agreed to?

- Are milestones for transition of key activities included?
- Are clear roles and responsibilities for stakeholders defined?
- Are all execution plan elements laid out in the transition guidelines? Appendix Slide 1



## 4. Sustainability

Does the country plan include programmatic, management, financing strategies that will ensure sustainability of activities within the plan?

- Are elements for national capacity building, and transfer of responsibilities included
- Does the financing strategy include domestic resources

NOTE: For certain fragile/conflict-affect countries with low GDP, domestic financing may not be realistic Appendix Slide 2

## 5. Integration

Are the transition approaches aligned with national health priorities and planning?

- Is the planning process aligned with other domestic planning?
  - Joint External Evaluation (JEE)
  - Global Fund to Fight Aids, Tuberculosis, and Malaria (GFATM)
  - Global Financing Facility (GFF)
  - Country Multi Year Plan (cMYP)
  - National Health Sector Strategic Planning (NHSSP)

Are polio transition activities integrated into non-GPEI partner organizations that will be the future owners of both functions to maintain a polio-free world and functions relevant for other health initiatives?

## 6. Financing

Does the plan have a realistic budget and a sustainable financing strategy?

- Is there a realistic budget connected with specific activities?
- Is there a realistic and attainable financing strategy?
- Despite the financing strategy, is there a funding gap? If, so how much?
