1. Background

The Global Polio Eradication Initiative, mandated by the World Health Assembly to stop transmission of wild poliovirus, has reduced global incidence of polio by 99.9%. It is a partnership spearheaded by WHO, Rotary International, US CDC, UNICEF and Gavi, the Vaccine Alliance, and supported by BMGF. The programme supports Member States in carrying out surveillance and immunization campaigns and strengthening routine immunization, in order to stop polio transmission.

The incumbent will support the Executive Management Unit (EMU) which has been established through the Polio Eradication Strategy, 2022-2026 to implement recommendations emerging from a comprehensive governance and management review conducted by GPEI to restructure the programme to be fit for the purpose of polio eradication. The consultant will provide high level expertise on Risk and Performance management to support the identification of barriers to successful strategy implementation, the mitigation of potential effects and the improvement of programme effectiveness and impact. Working within the EMU the consultant will work across the partnership with Global Programme support and Regional Operations groups to improve operational management and facilitate strategic decision making at Strategy Committee and Polio Oversight Board level.
