11 The Gates Foundation has provided challenge grants to Rotary International since 2008. Since that time, Rotary and US\$ 1.385 billion was raised by Rotary and US\$ 1.385 billion to UNICEF and WHO through the GPEI. The amounts shown for the Gates Foundation reflect direct funding to UNICEF, WHO, UNICEF and Gavi, the Vaccine Alliance as well as challenge funding to third parties included in the subtotals nor in the bottom-line grand total. Rotary's contributions to the GPEI are through the Rotary Foundation. Every dollar raised by Rotary International is matched with two additional dollars from the Gates Foundation.

For 2011, the Foundation also provided \$430,000 to improve the quality of life for children suffering from polio-related disabilities in Pakistan during the 2010 polio outbreak.

12 The US Centers for Disease Control and Prevention, the Gates Foundation, Rotary International and the United Nations Foundation are counted in their own contribution line.

13 Funds available at UNICEF include the UNICEF Executive Board-mandated PSC rate of 8%. Due to a bilateral agreement reached between UNICEF USA (UUSA) and Rotary in December 2015, all contributions from Rotary have a cost recovery of 7%, and UUSA contributes 1% to allow compliance with the relevant UNICEF Executive Board decisions.

14 Since this partnership with UNICEF began in 2012, easyJet has raised US\$8.3 million and helped to vaccinate over 25 million children. This was part of the Change for Good initiative which involved two onboard collections for UNICEF per year for polio eradication – one on October 24 for World Polio Day and a second for the winter season from 1 December to 31 January.

15 'Other' includes contributions from AGFUND, British Airways, Chevron (Angola), Dangote Foundation, SCB/Brunei + Polio Points Initiative, Millennium Fund, Sanofi Pasteur, Saudi Arabian Red Crescent Society, Smith Kline Biologicals, Total E&P (Angola) and UNICEF National Committees (until 2011).

16 In addition to direct budget support from the Ministry of Health, the Federal Government of Nigeria allocated funding from World Bank loans to WHO (US\$ 95.61 million) and UNICEF (US\$ 184.7 million) and UNICEF (US\$ 184.7 million) and UNICEF (US\$ 184.7 million) to help implement the country's polio program. Nigeria's total domestic contributions towards its program includes direct budget support, World Bank loans and JICA Loan Conversion funds.

The Government of Pakistan has taken out four loans from the Islamic Development Bank worth: US\$ 227 million for 2013-2025, the French Development Agency (AFD) announced a new partnership with the Gates Foundation to fund polio eradication efforts and support climate-resilient health systems in Pakistan.

This includes a new concessional loan of up to €55 million from AFD with a principle buy-down of €20 million from the Foundation - to Pakistan to support WHO's polio operations in the country. These funds to WHO & UNICEF to help implement the country's polio program. The principal amount of the loan will be responsible for the interest payments. The figures represent the annual contributions

received by WHO and UNICEF by the government. These funds, along with the JICA Loan Conversion, are Pakistan's domestic contributions towards the GPEI budget for 2013-2026. As part of its increasing ownership of the program, the Government also funded infrastructure, security support and direct provincial contributions estimated by the Government to be over US\$ 100 million from July 2012 to December 2018.

18 The UNICEF 2010 figure includes US\$ 20 million in Regular Resources for oral polio vaccine plus an additional US\$ 15.12 million in Regular Resources and US\$ 6.80 million in other UNICEF Resources. For 2013-2017, the total in Regular Resources is US\$ 61.73 million and US\$ 2.79 million in other UNICEF Resources (excludes easyJet and Latter Day Saints Charities, which are reflected separately).
