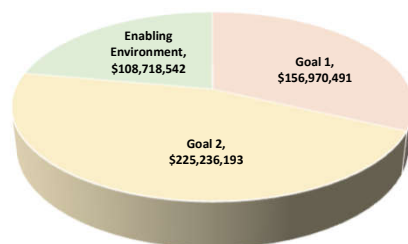

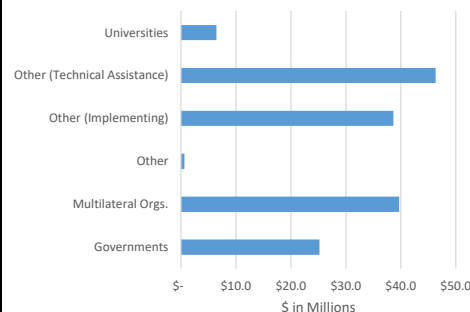

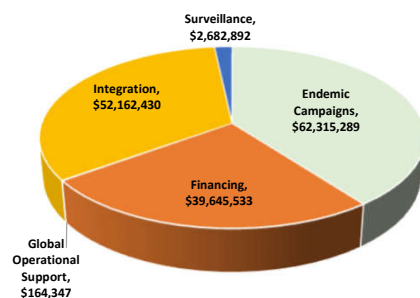

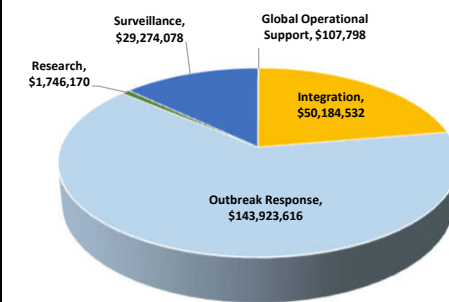

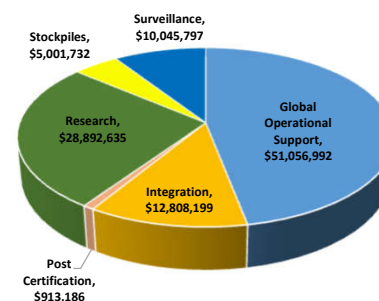

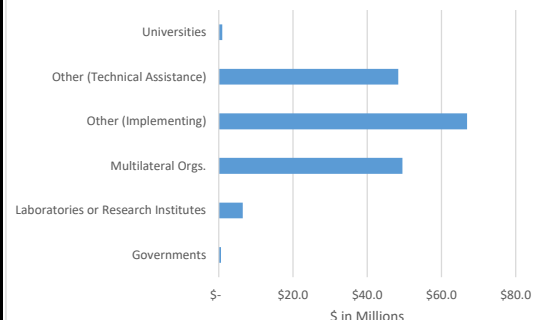
GF's 2024 Goal 1 non-FRR contributions are primarily intended to sustain and strengthen polio eradication operations in endemic countries, with a focus on three key areas: direct campaign delivery, integration with broader health services, and government co-financing. Investments support essential functions such as campaign operations, technical support to Emergency Operations Centers, and digital tools for workforce tracking and payments. Significant funding also enables the co-delivery of immunization services alongside nutrition and other primary health interventions, especially in high-risk and conflict-affected settings. Additionally, buy-down financing mechanisms incentivize continued domestic investment in polio efforts. Together, these investments aim to maintain momentum toward wild poliovirus interruption while reinforcing health systems and government accountability in Afghanistan and Pakistan.

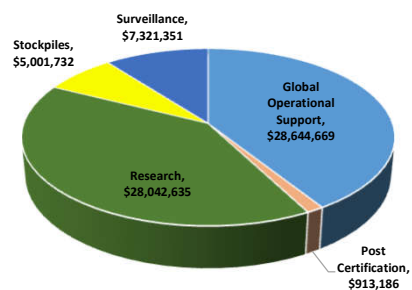

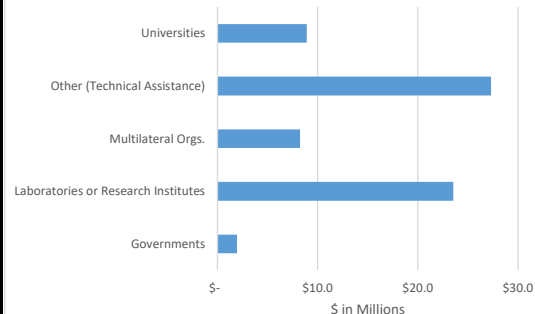
GF's 2024 Goal 2 non-FRR contributions are designed to enhance GPEI's capacity to respond rapidly to outbreaks of circulating vaccine-derived poliovirus (cVDPV) and mitigate risks in non-endemic settings. The largest share of funding supports outbreak response campaigns, operational surge capacity, and targeted technical assistance across high-risk geographies. Complementary investments strengthen routine immunization in fragile and conflict-affected areas, improve surveillance and laboratory systems, and expand the use of digital tools such as geospatial tracking and microplanning. These efforts aim to quickly interrupt transmission, reduce the risk of new outbreaks, and build resilience in health systems that remain vulnerable to poliovirus resurgence.

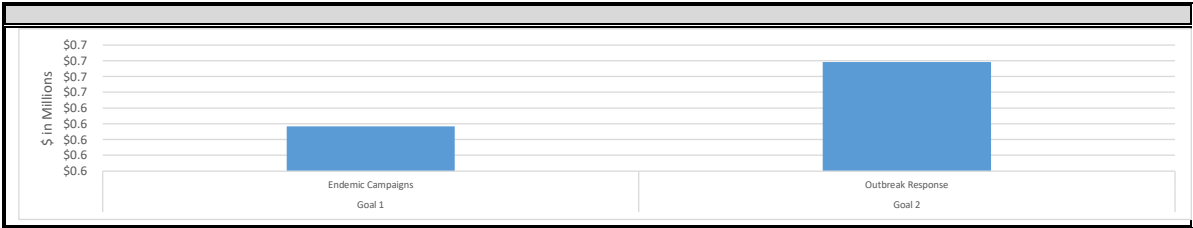
What is the programmatic purpose/intended outcome of the contributions?

GF's cross-cutting non-FRR contributions in 2024 support the systems and innovations that enable GPEI to function effectively across both eradication goals. These investments fund global coordination and operations, cutting-edge research on next-generation vaccines and antiviral tools, and the continued strengthening of surveillance infrastructure. Key areas include support for vaccine stockpiles, data and analytics platforms, and efforts to ensure containment and certification readiness. By sustaining the backbone of polio eradication infrastructure and driving innovation, these investments help ensure the program can adapt, respond, and ultimately succeed in a dynamic global health landscape.

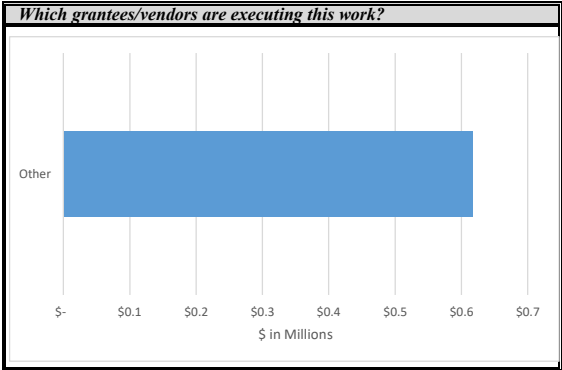
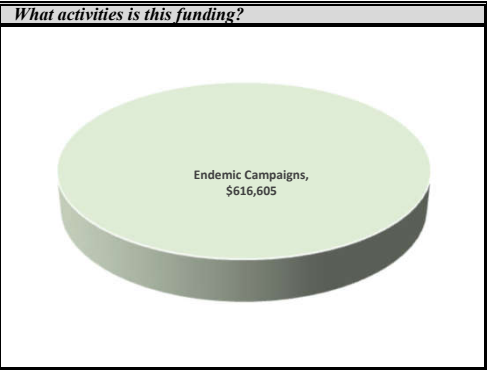
